Having the capacity of 10.000- 15.000 pieces of ready garment sewing and 10.000-15.000 pieces of part printing, Fita production also includes 3000-5000 pcs of embroidery per day. This makes a total of 3000000 pcs per year. All the production is export related.

## Production Phases

### Cutting

In this phase, fabric is spread in accordance to the Production Schedule. While spreading, fabric quality check is done and fabric with errors are seperated from the others.

The fabric with proper quality check is cut and then brought to the classification section to be matched with correct parts.

### Printing and Embroidery:

Products in this phase are printed and embroidered %100 compatible to the production sample.

After quality check, products are brought to the classification sector.

Before mass production, a production sample is prepared and sent to the customer to get feedbacks and ok to produce orders.

Afterwards, a band to produce most efficient and qualified product is formed and mass production begins.

Completed products are brought to the Quality Control section where experienced supervisors and workers handle them %100. Then the packing is done as the customer requests.
